## CERTIFICATE OF NO IMPEDIMENT FOR THE ESTABLISHMENT OF INNOVATIVE STARTUPS

WITH REGARD to Decree Law 179 of 18 October 2012 regarding "Additional urgent measures for the growth of the country", confirmed with amendments by Law 221 of 17 December 2012 (hereinafter Law 221/2012), published in Official Journal no. 294 of 18 December 2012;

WITH REGARD, in particular, to Section 9, Articles 25 to 32 of Law 221/2012 governing "Measures for the creation and development of innovative startup enterprises";

WITH REGARD to Article 3 of the Decree on Immigration Flows (Prime Ministerial Decree of 25 November 2013), which envisages the entry of foreign nationals to establish innovative startups pursuant to Law 221/2012, where the requirements envisaged by that law are satisfied and where said foreign nationals will have self-employment status with the enterprise concerned;

**WITH REGARD** to the guidelines issued on <u>dd/mm/yy</u> by the Ministry of Economic Development in agreement with the Ministry of Foreign Affairs, the Interior Ministry and the Labour Ministry;

**WITH REGARD** to Articles 26 and 27 of Legislative Decree 286/1998 and Articles 39 and 40 of Interministerial Decree 850/2011 concerning entry visas, entry for self-employment (Official Journal no. 280 of 1 December 2011);

**WITH REGARD** to the Ministry of Economic Development's Departmental Decree of <u>dd/mm/yy</u> establishing, in that same Ministry, an Italia Startup Visa Committee;

WITH REGARD to the application and documentation submitted on <u>dd/mm/yyyy</u> by <u>First Name and Surname</u>, born in <u>town/city (country)</u> on <u>dd/mm/year</u>, of citizenship <u>country</u>, identity document/passport no. <u>yyy</u>, issued on <u>dd/mm/yy</u>, resident in <u>town/city (country)</u>; for the purpose of entry for self-employment to establish an innovative startup in the territory of Municipality/Region: <u>name of Municipality/Region</u>;

The applicant having **OBTAINED** the Certificate of No Impediment for the purpose of entry, issued on <u>dd/mm/year</u> by the Questura of <u>town/city</u> in accordance with Article 39(5) and (6) of Presidential Decree 394/1999;

**HAVING EXAMINED** all the characteristics of the innovative startup project and having verified that the requirements of financial standing and all conditions envisaged are met, the Italia Startup Visa Committee hereby issues the following certification, which shall be valid for three months:

## **CERTIFICATE OF NO IMPEDIMENT**

so that the relevant diplomatic or consular mission may issue the entry visa for self-employment in a startup business.
